FIAP was established as a non-profit organisation concerning any person who agrees to these Statutes, and which is governed by these statutes and the amended Act of August 7, 2023, regarding non-profit associations and foundations.

#### 1. NAME, SEAT AND DURATION

- 1.1. The association bears the name of "Fédération Internationale de l'Art Photographique" in short 'FIAP' and this in any language.
- 1.2. FIAP is headquartered in the Grand Duchy of Luxembourg, in the commune of Kayl.
- 1.3. FIAP enjoys unlimited duration.

## 2. GOALS OF FIAP

- **1.**FIAP, whose origins date back to 1950, pursues the following goals:
- a) Develop and promote worldwide photographic knowledge from an artistic, educational and scientific standpoint, in accordance with the principles of UNESCO, as set out in its Constitutive Act signed in London on 16 November 1945.
- b) Create friendly and fraternal connections in the field of photography among all affiliated members.
- c) All political, ideological, racial or religious considerations are entirely excluded from the activities of FIAP.
- 2. The means to pursue the objectives of the Federation, both in Luxembourg and abroad, according to FIAP's capabilities and the requirements of each era, are as follows:

  The means to pursue the objectives of the Federation, both in Luxembourg and abroad, according to FIAP's capabilities and the requirements of each era, are as follows:
- a) The organization of seminars, conferences, and video conferences; the establishment and operation of photographic workshops; the organization of photographic excursions; the organization of meetings and congresses; the organization of photography exhibitions; the presentation of digital projections; the publication of magazines, books, albums, studies, and writings in the press and on the Internet; the organization of photography competitions; the granting of its patronage to national and international photography competitions; the granting of its auspices to national and international photography events; the establishment and operation of Photography Exhibition Centers; participation in competitions, exhibitions, or other artistic events; the creation and operation of a photography museum, a library, and a photo library; and, in general, the facilitation of its members' participation in any event or area of photographic interest, in order to enable the exchange of experiences and opinions and to showcase the artistic work of its members.
- b) The connection and cooperation with other organizations in Luxembourg and abroad through the implementation of joint programs and meetings between individuals and groups.
- c) Participation in the initiatives and programs of the European Union, state organizations, private and public entities, and national and international organizations for the promotion of the artistic work of its members, and cooperation with public authorities of the Grand Duchy of Luxembourg and abroad, as well as with associations, foundations, museums, legal entities, research centers, and citizen groups in Luxembourg and other foreign countries with similar objectives.
- d) Participation in international associations or organizations that pursue similar objectives, as well as in committees, councils, conferences, exhibitions, and national or international events related to the objectives pursued by the Federation at local, national, and international levels.
- e) The establishment of working groups and scientific or artistic committees.

- f) The use of media and social networks to inform the public about matters related to photography in general.
- g) The coordination of the Federation's activities is carried out through constant contact between its members and the media and social networks.

#### 3. FUNCTIONING AND STRUCTURE OF FIAP

2.

3.

- 3.1. The functioning of FIAP is governed by these Statutes and by its Internal Regulation.
- 3.2. The minimum number of members is set at two.
- 3.3. FIAP consists of Operational Members, Adhering Members (Regional, Local and Individual) and Honorary Members:
- a) Operational Members are federations or associations having an action at a national level, in a Sovereign State that is a member of the United Nations, whose name as registered by the United Nations will be used in all the FIAP documents to define the origin of an Operational Member. A single affiliation as Operational Member is possible per sovereign state. Exceptionally, for reasons of continuity in the history of FIAP, federations or associations that in the year 2014 were members of the former non profit French association FIAP are also considered operational members, with the same rights, even if they do not meet the above-mentioned conditions. Given the transitional nature of this status, in the case of removal or resignation, they will automatically lose this right and will no longer be able to join as operational members.
- b) Regional Adhering Members are associations comprising mostly clubs and associations of photographers. The number of regional members is not limited.
- b) Local Adhering Members (ILFIAP) are clubs or local associations operating at the national level within a Sovereign State, a member of the UN, whose name registered with the UN will be used in all FIAP documents to define their origin. They consist solely of individual photographers and not other clubs or associations. The number of local members is not limited.
- c) Individual Adhering Members are the persons, professional photographers or amateurs who are affiliated with an Operational Member for as long as they maintain the status of affiliates.
- d) Honorary Members are persons appointed for life by the General Assembly, for their outstanding contribution to the development of FIAP.
- 3.4. The supreme authority of FIAP is the General Assembly.
- 3.5. FIAP is directed and administered by an administrative council known as the 'Board of Directors.
- 3.6. The official languages of FIAP are those used during the General Assemblies and in which the minutes, documents and official texts of FIAP are written, namely, French and English. The minutes, documents and official texts of FIAP may be translated into German and Spanish. In case of diverging interpretations in the translations of official texts, the French text shall prevail.
- 3.7. FIAP's financial resources are the proceeds of various fees, medals and other services, individual donations and potential subsidies.
- 3.8. The financial year of FIAP begins on 1<sup>st</sup> January of each year.

## 4. MEMBERS

4.

- 4.1. Any federation, association or club who wishes to join FIAP must submit a written request which must contain the commitment to comply with the statutes and regulations of FIAP, to the Board of Directors.
- 4.2. Applications for membership as an Operational Member fall under the remit of the General Assembly. While awaiting the next general assembly, the new operational members are affiliated provisionally by the Board of Directors.
- 4.3. Applications for membership as a regional or local adhering member fall under the remit of the Board of Directors. In case of difficulties in determining the regional or local nature of an individual member, it shall be the responsibility of the Board of Directors to assess the true nature of the association concerned.
- 4.4. Individuals, professional and amateur photographers affiliated to an Operational Member are automatically Individual Adhering Members of FIAP.
- 4.5. Operational membership shall terminate with a written resignation letter notified to the Board of Directors or for serious reasons. Serious reasons are notably:
- a) non-payment of fees;
- b) infringement of the statutes and/or internal regulation;
- c) loss of representation in a given Country.
- 4.6. The procedure to exclude an operational member is regulated by the Internal Regulation. The decision to exclude an operational member is taken by the General Assembly acting by a majority of two thirds of the votes of the members present or represented. In the event of serious breaches of obligations (serious reasons) by an operational member, the Board of Directors may temporarily suspend this member pending the General Assembly's decision on exclusion.
- 4.7. Regional or local adhering membership shall terminate with the written resignation notified to the Board of Directors or for serious reasons. Serious reasons are, notably:
- a) non-payment of fees;
- b) infringement of the statutes and/or internal regulation;
- 4.8. The procedure to exclude a regional or local adhering member is regulated by the Internal Regulation. The decision to exclude a regional or local adhering member is taken by the General Assembly acting by a majority of two thirds of the votes of the members present or represented. In the event of serious breaches of obligations (serious reasons) by a local adhering member, the Board of Directors may temporarily suspend this member pending the General Assembly's decision on exclusion.
- 4.9. Individual Adhering membership shall terminate automatically upon disaffiliation from the Operational Member.
- 4.10. In compliance with its Statutes, FIAP shall safeguard the autonomy of its various members.

#### 5. THE GENERAL ASSEMBLY

5.

- 5.1. The General Assembly is composed solely of Operational Members who have fulfilled their statutory obligations. It is chaired by the President of FIAP and in his or her absence by one of the two vice-presidents.
- 5.2. Every Operational Member is entitled to a single vote.

- 5.3. In case of impediment, an Operational Member may be represented by another Operational Member or by a member of the Board of Directors by proxy. Members of the Board of Directors may vote for the Operational Member of their origin under the same conditions. Apart from the vote of origin, a member of the Board of Directors or an operational member may have as many as two proxies at most. Voting by correspondence or by e-mail is not permitted.
- 5.4. Adhering Regional, Local or Individual Members have the right to attend the General Assembly without the right to vote.
- 5.5. The General Assembly decides sovereignly about general activities, the goals and purposes of FIAP. It elects and revokes the members of the Board of Directors.
- 5.6. The General Assembly is convened by the Board of Directors once a year between the months of August and December and can take place either in Luxembourg or abroad.
- 5.7. The General Assembly meets every two years in congress, which may take place either in Luxembourg or abroad.
- 5.8. The General Assembly may be exceptionally convened, in Luxembourg or abroad, by the Board of Directors, as many times as required for the purposes of the association. The General Assembly must be convened by the Board of Directors when 20% of the Operational Members, having fulfilled their statutory obligations, submit a written request within a period of 6 months from the date of the submission of the petition to the Chairperson.
- 5.9. The individual convocations for the ordinary and extraordinary assemblies, sent by mail or electronically, made three months prior by the Board of Directors, must be accompanied by an agenda.
- 5.10. A deliberation of the General Assembly is necessary for the following matters:
- a) Amending statutes;
- b) Appointing and removal of members of the Board of Directors;
- c) Approval of budgets and accounts;
- d) Dissolution of the association;
- e) Establishing annual fees, which may not exceed the amount of two thousand euros (EUR 2.000,00);
- f) Approval of management and activity reports by the Board of Directors as well as the annual financial statements prepared in accordance with the provisions of Article 18 of the law of August 7, 2023;
- g) Appointing two auditors.
- 5.11. Decisions and resolutions shall only be taken regarding the items on the agenda.
- 5.12. The General Assembly shall vote by show of hands, unless a secret ballot is requested by at least five members. The votes for the election of the members of the Board of Directors are always made by secret ballot.
- 5.13. Decisions are taken by a simple majority of the votes expressed. Abstentions shall not be considered as votes. In the event of a tie-vote, the proposal will be rejected.

## 6. ADMINISTRATIVE COUNCIL - BOARD OF DIRECTORS

6.

- 6.1. FIAP is administered by a Board of Directors comprising nine people.
- 6.2. The Board of Directors is composed of a Chairperson, two Vice-presidents, a Secretary-General, a Treasurer and four Members.

- 6.3. The members of the Board of Directors are elected for a term of 4 years. Every two years elections take place, to designate alternatively:
- a) The Chairperson, a Vice-president, the Treasurer and two Members on the one hand,
- b) the other Vice-president, the Secretary-General and the other two Members on the other hand.
- 6.4. Candidatures for elections focus on a position defined within the Board of Directors and must be submitted at least four months prior to the elections. Any new candidatures must be supported by the Operational Member of the Country of the candidate and at least three other affiliated Operational Members, including one at least belonging to a continent other than that of the Country of the candidate. Candidates must speak one of the two official languages of FIAP, namely French or English. These conditions do not apply to the Members of the Board of Directors who wish to renew their candidature or to become a candidate for another position on the Board of Directors. Candidates for the posts of President and Secretary General must be fluent in the two official languages at FIAP.
- 6.5. If a position on the Board of Directors becomes vacant, the Members of the Board of Directors may appoint a person of their choice. Provisional appointment of this person will terminate at the following General Assembly.
- 6.6. Members of the Board of Directors are eligible for re-election. The newly elected members take office at the end of the Congress.
- 6.7. The Chairperson represents FIAP in all circumstances, in all acts of civil life and during legal proceedings. He or she steers the work of the association and presides over the deliberations of the Board of Directors. If unable to attend, the Chairperson is replaced by the most senior Vice-president.
- 6.8. The Secretary-General is responsible for drafting the documents of the association and the minutes of general assemblies and of the meetings of the Board of Directors. Official documents and correspondence shall be signed by the Chairperson and the Secretary-General or their replacements.
- 6.9. The Treasurer manages the finances. He or she is responsible for the collection of fees, checking payments of lists of affiliates and keeping the accounts. The Treasurer shall keep an inventory of all the property of FIAP. Persons with the authority to sign financial transactions are the Chairperson, the Treasurer and any other person designated by the Board of Directors. Dual signature is required for amounts exceeding the sums established under the Internal Regulation. At the end of each fiscal year, which corresponds to the calendar year, the Treasurer shall submit the accounts to the auditors and to the Board of Directors.

## 7. AMENDMENT OF STATUTES

The amendment of Statutes is conducted pursuant to the provisions of Articles 14 and 15 of the law of August 7, 2023.

## 8. DISSOLUTION OF FIAP

7.

- 8.1. The dissolution of FIAP must be announced by the General Assembly, convened for this purpose pursuant to the provisions of Article 25 of the law of August 7, 2023.
- 8.2. The remaining assets of FIAP will be awarded to one or more cultural internationally-known organizations.

## 9. INTERNAL REGULATION

The Board of Directors will establish an Internal Regulation which specifies the rules for the application of these Statutes.
